SUBJECT: Authorize the purchase of pipe locator equipment in an amount not to exceed \$12,500.

ISSUE:

Shall the City Council Authorize the purchase of pipe locator equipment in an amount not to exceed \$12,500?

GENERAL MANAGER'S RECOMMENDATION:

It is recommended that the City Council the purchase of pipe locator equipment in an amount not to exceed \$12,500.

FISCAL IMPACT: Not to exceed \$12,500

This item is not included in the FY 2026 budget. This would be expended from Water Fund reserves in the amount of 6,250 and Sewer Fund Reserves in the amount of \$6,250. There are enough reserves available for this purchase.

DISCUSSION:

The City must be able to locate our water lines to maintain service connections. This pipe locator will be mainly used to locate water copper service lines from the meters to the main lines. In the past we have encountered situations where the water service lines did not line up with the meter boxes. Essentially, we are guessing at where the services are located.

We are frequently required by Dig Alert to locate water and sewer services throughout our city, so this tool will be an asset to our department. We will also be able to locate and trace electrical lines as well. Sewer will be a little more difficult to locate, due to them being plastic or clay. A leader metallic line can be inserted in sewer line to assist with locating. The cost should be split between Water and Sewer 510/520 funds.

The first quote (#1) has the taxes and shipping included and is my recommendation to purchase. The second quote (#2) doesn't have taxes or shipping included but the subtotal is more than quote #1.

CONCLUSION:

Staff recommend that the Council the purchase of pipe locator equipment in an amount not to exceed \$12,500.
